- Board of Governors Election Information (Exec) graduate students have a right to participate in this election for a position on the Board of Governors. Any interested individual can run by collecting signatures and putting their name forward. Currently there is an issue with voting, as is conducted online, but will be resolved shortly. VP Academic states that if we can fill this position, this time, with a graduate student we will in effect have two arms to work with in practice. One on the BoG and one in the Senate, will add more strength to our position in the university community and increased representation.

Motion to approve numbers by Civil Engineering, seconded by Forestry. All those in favour = yes, opposed = none.
